ABOUT CREDIBILITY ALLIANCE

VISION

Avoluntary sector which is responsive to the needs of the society, is democratic and transparent in its functioning and accountable to all concerned.

MISSION

To build the credibility of the voluntary sector through creation and promotion of norms of good governance and public disclosure.

THE GENESIS

Credibility Alliance is a consortium of voluntary organizations committed to enhancing accountability and transparency in the voluntary sector through good governance. It is an initiative that has emerged from within the sector. In December 2001, Childline India Foundation and Charities Aid Foundation organized a meeting for voluntary organizations, funding agencies and corporate entities on the 'Need for an NGO Consultative Framework'. At this meeting it was decided that a working group would be constituted which would develop a set of 'minimum' norms for good governance, accountability, and transparency of the voluntary sector. It was decided that the process of defining and developing norms should emerge through an inclusive and participatory method. Hence this meeting was followed by a two year dialogue with over 15,000 voluntary organizations across the country. In November 2003, during a national level workshop in Delhi, the constituents of the voluntary sector decided to set up a separate organization called 'Credibility Alliance' to promote mechanisms, which would enhance the voluntary sector's image and credibility. Credibility Alliance strives to build trust among the stakeholders of an organization. We do this by advocating norms for public disclosure and good governance that will help organizations become more transparent and accountable to their stakeholders

OBJECTIVES

- Development of norms of governance, based on consensus, through participation and consultation.
- Promotion of an accreditation system for the voluntary sector.
- Promotion of capacity-building initiatives for voluntary organizations to enable compliance with norms.
- Policy advocacy for enhanced credibility, acceptability and recognition
 of the work done by the voluntary sector in the eyes of the
 government, the donor community, the corporate sector, the media
 and the public.

LOOKING BACK

Norms Development and Improvement

One of the objectives of Credibility Alliance is to develop a comprehensive directory of norms, sensitive to the spatial and functional diversity of the sector. This in turn will enable organizations of different kinds and sizes to adopt them. Credibility Alliance is aiming to develop norms for generic programme evaluation and also norms for specific thematic areas. Hence a Norms Committee has been set up consisting of experts from the voluntary sector, consultants, and academics. The key mandate of the Norms Committee is to review the current norms, to develop norms for programme evaluation, and to contextualize the generic criteria for programme evaluation to different sectors in the development field. The Committee started functioning in December 2006. The first meeting was held on December 23rd 2006. This was followed by a second and third meeting on January 16th 2007 and March 3rd 2007 respectively.

Accreditation:

The main purpose of the accreditation exercise is to develop a cost effective mechanism of periodic evaluation for voluntary organizations in India. Accreditation of voluntary organizations in India is a relatively new concept. However, we have been in dialogue with various stakeholders regarding the importance of accreditation. As a result, we developed concrete plans to make it a reality for the voluntary sector here. Some of our actions are mentioned in the following sections.

Project with Government of Gujarat

The Government of Gujarat has endorsed the initiative of Credibility Alliance. The Tribal Development Department, Government of Gujarat has agreed to incorporate the accreditation model in their grant making process. Credibility Alliance has submitted a proposal to the Tribal Development Department for accreditation of 100 voluntary organizations.

Project with YASHADA

Yeshwantrao Chavan Academy of Development Administration (YASHADA) is the apex training and research institute of the Government of Maharashtra. YASHADA and Credibility Alliance signed a MoU on June 1st 2006 to express mutual interest in the area of 'Documentation and accreditation of voluntary organizations'. As part of this agreement, a pilot project on accreditation for 30 voluntary organizations is in process.

Pilot project with Give India

A pilot project on accreditation has started with 10 Give India partners in Mumbai and Pune. The process started with Desk Review of documents provided by individual organizations. First visit to an organization was made on January 31st 2007. It was followed by a second visit to verify original documents and to field visit their programs. A total of eight organizations participated in the pilot project.

After the pilot phase was completed, the experiences and learning are being discussed and debated extensively within the sector so that a final process of accreditation of voluntary organizations in India will emerge.

Membership drive

The basis for success of the initiative is the acceptance of the norms by a large number of voluntary organizations and their commitment to follow the norms. At present there are 462 voluntary organizations enrolled as members. Credibility Alliance has a membership base of 49 in the North Zone; 115 in the South Zone; 141 in the East Zone; 84 in the West Zone; 42 in the Central Zone; and 31 in the North East Zone.

Formation of State Committees

State Committees are an institutionalized mechanism for broad basing the initiative and linking it to the ground reality. State Committees have been envisaged as decentralized local bodies, which actively promote the process of Credibility Alliance in their respective states. Nineteen active State Committees have been formed in various states and union territories as of now. Credibility Alliance is striving to strengthen the existing state committees so that they can take full ownership of membership development, accreditation goals for their own states, engage in liaison and advocacy work with state government and media. 21 State Committee meetings were held during 2006-2007.

Experiences of a CREDIBILITY ALLIANCE member

"We wanted to remain transparent and accountable from the beginning. After becoming a member of Credibility Alliance we were benefited not only in terms of developing better understanding about transparency and accountability issues but we also received guidance on how to make it a reality for our organization. Our sociation with Credibility Alliance has resulted in PRISM feeling more aware about its responsibilities towards different stakeholders. It has become a rule within our organization to consider feedback and suggestions from different stakeholders. For example, during our Annual General Meeting we have started inviting individuals from different NGOs, academicians, researchers, administrators to be present as witness of the proceedings. We have started translating our Annual Reports in Bengali. We disseminate them in cluster meetings so that all our beneficiaries and community members are informed about the major aspects of our work. We realized that there was a need for us to develop participatory mechanisms of governance. Hence we took a policy decision that one nominated member of our Governing Body would be from the community organizations and groups with whom we work. This year our Self Help Group federation nominated its Secretary to our Governing Body.

We feel comfortable when we think of our work in the light of the Right to Information Act 2005. Although it's not applicable to voluntary sector organizations, we feel proud that we comply with what we preach for in society. We believe the steps we have taken to improve our accountability and transparency have helped us move towards becoming a 'Peoples organization'."

ACCEPTANCE OF CREDIBILITY ALLIANCE BY DIFFERENT STAKEHOLDERS

Acceptance by Central and State Governments

i) The founding members of Credibility Alliance have made recommendations on an accreditation process to the Planning Commission's Steering Committee.

ii) Gujarat Government is processing our proposal to accredit 100 voluntary

organizations.

iii) Orissa government has formed a task force on "strengthening civic engagement for government- NGO partnership" and they invited Credibility Alliance as a member to it.

iv) Credibility Alliance has started a pilot project on accreditation in agreement with YASHADA, Pune for 30 Voluntary organizations.

v) The National Commission for Women has appreciated the initiative of Credibility Alliance.

Acceptance by Donor Agenices & Voluntary Organizations

i) Organizations such as Voluntary Services Overseas (VSO), Sehgal Foundation, and Packard Foundation organized workshops to promote norms of Credibility Alliance amongst their partners.

ii) Packard Foundation is helping its 42 partner members financially so that they get Credibility Alliance membership for two years. Smile Foundation will be sponsoring 100 organizations for membership. iii) Organizations such as HelpAge

iii) Organizations such as HelpAge India, GiveIndia, and Smile Foundation have endorsed the norms of Credibility Alliance.

Partnerships with Organizations with Similar Objectives Internationally

i) Credibility Alliance, GuideStar International and Give India entered into a tripartite agreement to promote a web based disclosure system to enhance transparency within the voluntary sector. The agreement was made for the period June 1st 2006 – March 30th 2007.

ii) Credibility Alliance has had interactions with AccountAbility in the UK, the PCP in Pakistan, the One World Trust and PCNC in the

Philippines.
