

Message from Chairperson A Decade Later ...

The completion of 10 years is a landmark event for an organization. It calls for celebration even as it offers an opportunity for reflection. The reasons for celebration are many. Thanks to the efforts of Credibility Alliance the issue of norms for the voluntary sector has been widely accepted. I recall attending some of the initial meetings when these norms were sought to be formulated. The debates were heated among the protagonists that included members from the voluntary sector, donors and audit firms.



The issue debated was what it would take to ensure that accountability and transparency were established within the voluntary sector. There was no doubt that it suffered from an image problem. This remains so to this day. And hence the Credibility Alliance needs to re- double its efforts to reach out to more and more NGOs. In 2005 it had 158 members which rose to a 1,000 by 2010.

Credibility Alliance was registered under the Societies Act with 11 member organizations located in nine states. By the following year committees had been set up in 19 states to promote its Norms. Since then three categories of Norms have come into play: desirable, minimum and basic. The last was introduced relatively recently to ensure that the CA norms were accepted as widely as possible. The voluntary agency has to self-certify, which involves it displaying its basic documents such as registration papers, Pan number and so on, on its website; thereafter an NGO based nearby confirms that it is located where it is.

While the categories of norms have increased, there have been other changes as well.

Leadership to it has also been provided by distinguished civil society stalwarts. Credibility Alliance's first chairperson was B.N. Makhija, who after retirement from government service has been serving on the boards of public, private and joint sector companies as well as working with the voluntary sector at the local, state and national levels. Mathew Cherian, who took over from Makhija, has been associated with donor agencies, the government and the voluntary sector. He was national director Oxfam, former chairperson of Mobile Creches and Resource Alliance, and served as a member of the NGO task force of the Planning Commission. Currently he is CEO of HelpAge India. The third chair, Jagadananda is a social activist working with the tribal and rural poor. He was a visiting fellow at CIVICUS World Alliance for Citizen Participation, based at Harvard University and was nominated as the Orissa State Information Commissioner in 2008. Poonam Natarajan who succeeded him is a major figure in the disability sector and is currently chair of National Trust.



Despite such able guidance, CA is facing a financial crunch. There are several new initiatives we are working on to overcome it. One is to position ourselves as Corporate Social Responsibility knowledge partners; we have produced a major tome on CSR, as well as slim Learner Series publications. But we will need to define a niche for ourselves as several champions of this new area have emerged, the foremost being the government body, the Indian Institute of Corporate Affairs.

The IICA has launched a major initiative among the 14,000 companies in the country that have had an average of Rs. 5 crores net profit for the last three years. It will function as a hub to provide a nine month certified CSR professional course; after due diligence of NGOs it will showcase those that have passed muster; the good projects that NGOs develop -- replicable, do-able, scale-able -- will be put up on its website; IICA will train NGO staff to build their capacity and develop evaluators of NGO- CSR projects and display the list on its website.

There are numerous other players in the field and CA will have to negotiate space for itself. The area is huge and with sensible positioning it can make a significant contribution to this sphere. But there is no time to waste. It needs to get cracking while it speeds up the process of promoting norms and clearing those that the CAC has examined. The latest board meeting has sanctioned the higher fees that the large and medium category of NGOs will be charged. The assessors will also be paid more for their efforts. All this will increase CA's income. Indeed this is its core strength and it will do well to capitalize on it. One evaluation suggests that it can raise its income sufficiently to meet its essential expenditure [rent and staff salaries].

Credibility Alliance can do with greater visibility. The positive aspect is that there is much that can propel CA into greater prominence. The NGOs that have been sanctioned the desirable norms are among the most remarkable in the country. They are working in the whole gamut of development, as is evident from CA's latest publication, Development Impact. Their contribution should be brought into the public domain by Credibility Alliance. As well as to the notice of the Government. For precisely in the areas that the Government has failed, the voluntary sector has succeeded. It has provided succour and hope to the most vulnerable even as the Government has focused on maintaining the status quo.

Rajiv Gandhi recognized this fact and proposed to give the voluntary sector more scope. Not so the dispensations since then. My gut instinct is that CA take up this issue even if it involves confrontation with the powers that be. But before we do so CA's feet need to be on firmer ground. It has major opportunities before it and major responsibilities. It should take the one even as it shoulders the other.

About Credibility Alliance

Credibility Alliance (CA) is a consortium of Voluntary Organizations and networks working for the promotion of Good Governance in the Voluntary Sector and enhancement of its credibility in the eyes of the stakeholders. CA intends to promote Transparency and Accountability in the Voluntary Sector through self disclosure mechanisms. Following a two-year long extensive consultative process involving more than 500 Organizations from across the country, the Alliance emerged as an initiative from within the sector and was registered in May 2004 as an independent, not-for-profit organization. Currently there is very little mechanism within the Sector to give assurance about an organization to its stakeholders, to the donors it works with. As a result, VOs having good track record go unnoticed and the Sector also is generally questioned for lack of accountability mechanism. Credibility Alliance addresses this issue, primarily through Accreditation of voluntary Organizations, which is carried out through a structured process, whereby CA recognizes an organization which complies with the norms developed by CA, which assure that certain basic parameters are in place in an organization. Credibility Alliance has been working to build and promote self-regulatory frameworks by defining various norms and standards for the Organizations to adhere to and in doing so help them demonstrate greater transparency and accountability of the overall sector. Credibility Alliance believes that accountability of VOs is the cornerstone of good governance and a pre-requisite for an effective democratic participatory process. A Voluntary Sector, which is responsive to the needs of the society, is democratic, is transparent in its functioning, and is accountable to all concerned. To build the credibility of the voluntary sector through creation and promotion of norms related to good governance and public disclosure.

Objectives

A fast emerging voluntary sector in our country is a major contributor in the development of Indian society. Hence, it's but natural that the rapid growth of the sector in terms of its size, number and resources has generated many a question on the credibility of its constituents. Despite this, the existing regulatory bodies in our country have made no efforts to set up adequate mechanisms or processes to assess the credibility of voluntary Organizations in concrete and verifiable terms. Keeping this in view, the Credibility Alliance has been working hard to build and promote self regulatory frameworks by defining various norms and standards for the Organizations to adhere to and in doing so help them demonstrate greater transparency and accountability of the overall sector. This is achieved through:



- Establishing norms of transparent governance, based on participation, consultation, and consensus;
- Developing and promoting an Accreditation system for voluntary Organizations;
- Providing capacity building support to Organizations for enabling them to improve conceptual understanding of what governance and finance practices are necessary, what is the existing legal

framework, and how to comply with the agreed norms and accountability practices; and Conducting policy advocacy with government, the donors, the corporate sector, the media, and the overall public for ensuring better recognition of the highly credible work being done by the voluntary Organizations.

Core Values of Credibility Alliance

Core Programme Areas

Programmatically, the Alliance focuses on the four Core Programme areas of Accreditation, Capacity Building, Networking, and Information Dissemination.

Accreditation by Credibility Alliance is a process through which a Voluntary Organisation is certified as an organisation

adhering to Accountability Norms and providing service of a reasonably good quality. The main purpose of the Accreditation exercise is to develop a cost effective mechanism of periodic evaluation for Voluntary Organizations in the country. As a step forward, Credibility Alliance undertakes Capacity Building initiatives by identifying and outlining the gaps in the Voluntary Sector. It does so by assessing the needs, locating and adopting the existing best practices and finally instituting programmes to







address those needs. Care is taken to integrate the Capacity Building initiatives with the observations emerging during the Accreditation process in a systematic manner. The Alliance has also established good networking with pivotal groups and individuals that helps a great deal in furthering the organization's mission and vision. Keeping this in view, Credibility Alliance, places a great deal of thrust on strengthening relationships,



exchanges, cooperation and partnership with and among various Voluntary Organizations. The Alliance sensitizes, spreads awareness, assists, educates and apprises on the recent developments, responsibilities and other critical issues pertaining to the Voluntary Sector by disseminating vital information to all the Voluntary Organizations.

Accreditation

Accreditation by Credibility Alliance is a process through which a Voluntary Organisation is certified as an organisation adhering to accountability norms and providing service of a reasonably good quality. The recognition helps the public and others to trust in the quality of its services. The Accreditation is provided only after ensuring that the organisation adheres to the Minimum Norms defined by the Alliance. The process begins as soon as an organisation voluntarily approaches the Alliance for receiving Accreditation.

Other value additions for the Voluntary Organizations are:

- Commitment to a set of Norms and recognition as an accountable, transparent and governance driven organisation.
- Building the professional capacity of the organisation through networking opportunities within a large membership base.
- Having a sense of accountability by bringing greater credibility to the sector as a whole




Regional Distribution

As on March 31, 2014, 401 Voluntary Organizations have been Accredited by Credibility Alliance. Out of these, 237 under Desirable Norms, 142 under Minimum Norms and including 22 Certified under Basic Norms. Around 107 Voluntary Organizations are in the process of getting accredited, all over India.

The software helps Credibility Alliance meet the objectives of enhancement of transparency for the overall Accreditation process, evasion of time delays and in maintaining a centralized database of all the Accredited Organizations and the VOs which are under the process of getting accredited. The salient features of the Software include:

- Auto Profile creation once CA approves the VO
- Profiling, processing application and documenting details of all the VOs in standardized format.
- Online Application desk reviews and eligibilities
- Automatic generation of information to Assessor as well as the VO regarding Assessor's visit
- Uploading Assessor's visit report and CA Review report for VOs
- Online sharing of review reports with VOs
- Automatic generation of e-mails after CAC meeting, regarding approval or clarification of accreditation.
- Online certificate generation for VO and acknowledgement option from VO.



As on 31.03.2014, 401 Voluntary Organisations have been Accredited by Credibility Alliance under Minimum & Desirable Norms including 22 Voluntary Organisations certified by Credibility Alliance under Basic Norms.



Central Accreditation Committee Meetings (CAC)

The Alliance has set up a Central Accreditation Committee (CAC) – a group comprising of Development experts from various fields and few Credibility Alliance Board Members. The Committee comprises of specialists and eminent experts, possessing skills in the areas of organisational management, finance, and social work, who subject the aspirant



Organizations to a process of rigorous scrutiny on the basis

of the norms and standards decided by the Alliance.

The Committee takes a holistic view of an applicant organisation on the basis of the documents submitted by it. Primarily, observations made by the expert assessors are taken into consideration.

During the reporting period, Eleven CAC meetings were held and altogether 112 files were presented, out of which 84 were

Accredited, under which 55

were Accredited under Desirable Norms and 29 were Accredited under Minimum Norms and remaining files were on clarification.

Preliminary Planning Meeting on 22.2.2014

Preliminary Planning Meeting for strategic areas of Credibility Alliance was organised on 22nd Feb, 2014. Ms.Poonam Natarajan, Dr. Gautam Vohra, Dr. Manoj Fogla, Mr.K.P. Rajendran and Ms.S.P.Selvi participated in this Meeting.





Brainstorm on the following initiatives and about CA:

- CSR Handbook, a publication initiative. The publication authored by Dr. Manoj Fogla is planned to be brought out in April,2014.
- Norms Review Process CA intends to have its Norms reviewed which were developed during 2003 and 2004.
- Developing Credibility Alliance Rating tool.

Capacity Building

Capacity Building initiatives of CA are planned by:

- Identifying and outlining the gaps in the Voluntary Sector,
- Assessing the needs,
- Locating and adopting the existing best practices and
- Finally instituting programmes to address those needs

'Capacity Building' refers to a process to increase the skills, infrastructure, and resources of individuals, Organizations and communities. Capacity building is a key strategy for the promotion, delivery and sustainability in voluntary sector.

Credibility Alliance focuses on the capacity building process to impart knowledge on the concepts and practices in implementing the same. The Credibility Alliance plans the capacity building initiatives to address the existing gaps by identifying and outlining the areas wherein awareness and conceptual understanding is required.

So far CA has organized about 8 workshops in which about 195 participants from various organisations participated.

Regional workshop for members on governance, FCRA and CSR are planned to be organised between Oct to Jan this year. Meetings on CA Norms are also planned with assessors during Oct to Jan.





During the 10 years, Credibility Alliance has organized 258 meetings and 4,422 participants attended the meetings.

Out of which 31 workshops were organized and 987 people attended the workshops.

National Consultation



National Consultation are organised by CA annually:

During the reporting year, various Capacity Building initiatives were undertaken by Credibility Alliance:

National Consultation on "Evolving Dimensions of Social Accountability in the Voluntary Sector" was held in association with The David Lucile & Packard Foundation.

In order to debate on the questions emerging and to enable sharing of experiences and knowledge and perspectives, CA organized a National Consultation of 2013 on "Evolving Dimensions of Social Accountability in the Voluntary Sector" at India International Centre, New Delhi on 23rd September, 2013.

Smt. Vandana K. Jena, Senior Advisor, Planning Commission, presided as the Chief Guest of the event.

Smt. Gayatri Subramaniam, Sr. Consultant School of CG & PP & Convener, IICA was the Guest of Honour of the event.

The Consultation was attended by about 111 participants which included eminent persons from the Voluntary Sector and Corporates as well. It also included participation of Confederation of Indian Industry (CII), SOSVA, Help Age India, GuideStar India, The David and Lucile Packard Foundation, Consultants & Chartered Accountants, PACS, Give India, Public Affairs Centre, Development Alternatives, TISS and Coca-Cola Foundation.



Smt. Vandana Jena, the Chief Guest, said that social accountability implies the engagement of civic organizations to express demands of public services and extract accountability from the local service





providers to improve service quality. According to Smt. Jena, social accountability is increasingly being recognized by state and non-state institutions as a means of increasing democratic governance and improving service delivery. Smt. Jena also stated that social accountability refers to a broad range of actions and mechanisms that citizens, communities, independent media deploy to hold public officials and public servants

accountable. According to guidelines, NGOs which receive 'substantial' funding from the government will come under RTI. She concluded her speech by stressing that the government and the NGOs need to

work together and in partnership for the development of the country. There is a need for the corporates to step in and NGOs to look forward to the CSR initiatives of the corporates for overall development.

Ms. Gayatri Subramaniam, Convenor of the National Foundation for CSR, said that the topic social audit has come at an appropriate time with the passage of Companies Bill as Indian Institute of Corporate Affairs is working on



the rules. She said that one of the rules which will help the voluntary organisations is the 2 per cent mandatory expenditure i.e. the companies are urged to spend 2 per cent of their profits on voluntary/development work which in turn will open a lot of avenues to the voluntary sector. Subramaniam also said that for this purpose the Ministry of Corporate Affairs, has set up the National Foundation for CSR, which is going to act as an enabler and facilitator to integrate the efforts of



Networking

CA has established association and works in close partnership with key Organizations to expand prospects of collaborative initiatives and high level engagements.

The Organizations include Planning Commission, Confederation of Indian Industry (CII), David and Lucile Packard Foundation, IDF-OI, TISS CSR, One World South Asia, Global Compact Network, Child Fund India, Edel Give Foundation, Action Aid, UBM India, Resource Alliance, Oxfam, Caritas India, Centre for Advocacy and Research, German Agro Action, World Bank, Sir Dorabji Tata Trust (SDTT) and Department of Public Enterprises (DPE).

During the year meetings were held with Planning Commission, CII, GCN and IICA.

CA also facilitates interaction between experts in different areas and promotes the sharing of ideas and information between the Voluntary Organizations and the experts. CA assists VOs to seek issue-based information in the sector that they are working in, which helps in building the professional capacities of VOs through training, thereby enabling them to increase institutional capacities. To this end, the Alliance has been working closely with like-minded Organizations like Give India, Oxfam India, GuideStar India, HelpAge India, VANI, National Foundation for India, Confederation of India Industry (CII), TISS CSR Hub, Sampradaan, India Policy Foundation, Global Compact Network, NEG-Fire, PRIA, Socio Research and Reform Foundation (SRRF) etc.

Information Dissemination

Voluntary Organizations are encouraged to increase their institutional capacities by seeking issue-based information and building their professional strength through imparted information and inputs received through participation in trainings. In the course of providing Accreditation to Voluntary Organizations, CA realized the critical need for enhancing understanding of Governance related principles and practices. With a view to address this need, the Alliance has launched an e-communique for the Voluntary Organizations titled "CA Learning Series on Governance and Disclosure Practices for Voluntary Organizations". These aim at serving as learning material, seek to help Organizations gain deeper insights in order to bring about desired improvements in their governance and accountability practices.




Organization Structure







